Giving and granting unto my Agent full power and authority to do and perform all and every act, deed and thing whatsoever that is necessary in the execution of this Durable Power of Attorney as fully as I might or could do if present and acting. I herby ratify and confirm whatsoever my Agent shall do in the premises by virtue of this authority.

I further declare that any act or thing lawfully done hereunder by my said Agent shall be binding on myself and my heirs, legal and personal representatives, and assigns, whether the same shall have been done either before or after my death, or other revocation of this instrument.
