

Exhibit A – Sample Language for Gift of Dogs to Adopt a Golden Atlanta

Upon my death, my Trustee shall distribute my Dog(s), _____, to Adopt a Golden Atlanta. It is my intent that my Trustee cooperates with Adopt a Golden Atlanta in finding a permanent adoptive home for my Dog(s). My Trustee should defer to Adopt a Golden Atlanta in making a determination as to the suitability of a particular adoptive home, or any other course of action concerning my Dog(s) as authorized herein. I direct my Trustee to reimburse Adopt a Golden Atlanta for all costs associated with the care of my Dog(s) until a permanent adoptive home can be found.

Adopt a Golden Atlanta is given full and complete control and authority regarding veterinary care and treatment of my Dog(s). All personal information about my Dog(s) and special instructions regarding care are listed on the attached schedule. I release, hold harmless and indemnify Adopt a Golden Atlanta harmless from any action or claim against Adopt a Golden Atlanta based on its decision regarding veterinary care and treatment made as provided in this paragraph.

I additionally direct my Trustee to make a lump sum donation of \$_____ to Adopt a Golden Atlanta for the service of locating a permanent adoptive home for my Dog(s). I additionally direct my Trustee to distribute \$_____ to the person adopting my Dog(s) to compensate for his/their lifetime care.

Exhibit B – Sample Power of Attorney for Providing Pet Care

I, _____, currently residing at _____ do make and appoint _____ (hereinafter my Agent), whose address is _____, as my true and lawful attorney-in-fact to do and execute any or all of the following acts.

I am the owner of the following pet(s), hereinafter my Pet(s):

From time to time, it will be necessary for me to leave my Pet in the care and custody of my Agent. I hereby give my Agent full permission and authority to:

1. Give consent for emergency veterinary treatment as needed by my Pet in the event I cannot be immediately reached at the time of the emergency. The determination of the need for such care may be made by my Agent.
2. To authorize all necessary veterinary treatment, including surgery or hospitalization, for my Pet(s) while in the care of my Agent. Further, my Agent is authorized to take any and all other necessary actions to provide for the safety and welfare of my Pet(s).
3. To perform any and all acts, as fully to all intents and purposes as I might or could if personally present, to include but not limited to the feeding, care, maintenance and supervision of my Pet(s).
4. To authorize payments for care, including food, veterinary care, grooming, exercise and socialization of my Pet(s).

Giving and granting unto my Agent full power and authority to do and perform all and every act, deed and thing whatsoever that is necessary in the execution of this Durable Power of Attorney as fully as I might or could do if present and acting. I hereby ratify and confirm whatsoever my Agent shall do in the premises by virtue of this authority.

I further declare that any act or thing lawfully done hereunder by my said Agent shall be binding on myself and my heirs, legal and personal representatives, and assigns, whether the same shall have been done either before or after my death, or other revocation of this instrument.

Exhibit C – Sample Language Providing for Dogs in a Will

Upon my death, my Executor shall distribute my Dog, _____, to _____, or if he is unable or unwilling to accept my Dog, to _____. If none of the above is able or willing to accept my Dog, my Dog shall be distributed to Adopt a Golden Atlanta. If any of the above listed persons accepts my Dog, my Executor shall make a lump sum distribution of \$_____ to them to compensate for the maintenance and support of my Dog.

If my Dog is distributed to Adopt a Golden Atlanta, it is my intent that my Executor cooperates with the Adopt a Golden Atlanta in finding a permanent adoptive home for my Dog. I desire that the adoptive home be a loving environment selected with the best interests of my Dog in mind. My Executor shall have the sole and absolute discretion to provide a cash bequest to the person adopting my Dog in the aggregate amount of \$_____. In addition, I direct my Executor to reimburse Adopt a Golden Atlanta for all costs associated with the care of my Dog until a permanent adoptive home can be found and distribute to Adopt a Golden Atlanta a cash gift of \$_____ for its assistance in my Dog's placement once a permanent adoptive home is found.
